## SECTION I. GENERAL INFORMATION

## Summary.

**1.1. Solicitation.** The intent of this Request for Proposal ("RFP" or "Solicitation") is to provide instructional kitchen deep cleaning services (the "Services) at the Culinary and Dr. Dukes Student Center Buildings in Largo, Maryland. and give firms an opportunity to present their qualifications and experience, to providing the scope of services in relation to the needs of Prince George's Community College ("PGCC" or "College")

The College anticipates awarding one firm; however, the College may award multiple firms to provide all of partial services. The awarded firms will be issued an initial one (1) year term with four (4) one-year renewal terms the College's sole discretion. The Contract value for all contracts issued under this RFP shall not exceed \$245,000 for the life of the contract/s.

**1.2. Procurement Regulations**. This RFP shall be conducted in accordance with College's Policies and Procedures. The procurement method is Competitive Sealed Proposals.

#### 1.3. Background.

Established in 1958, Prince George Community College is an award winning fully accredited public two-year institution offering credit programs leading to an associate degree, certificate, or letter of recognition. With a student body of approximately, 38,000 the College prepares its students for transfer to a four-year institution or for an immediate career. PGCC also offers extensive lifelong learning opportunities and noncredit, continuing education to those seeking career training or retraining, working to boost basic skills or pursuing new areas of interest. In addition to the College's academic focus towards student growth and achievement, the College culture is geared towards ensuring students succeed.

**2.2.** The Issuing Office shall be the sole point of contact with the College for purposes of the preparation and submittal of proposals in response to this solicitation.

### 3. Questions and Inquiries.

All questions and inquiries regarding this procurement must be directed to the individual(s) referenced with the Issuing Office above. Questions must be submitted in writing via email to the individuals listed above. Inquiries will receive a written reply/confirmation, submitted inquiries that are not confirmed by the College may not have been received. It is the sole responsibility of potential proposers to ensure inquiries/questions are received for response. Copies of replies will be sent to all other Offerors, but without identification of the inquirer. All such questions and inquiries must be received by the date and time as listed in the Solicitation Schedule of this RFP.

Potential proposers are advised that the College reserves the right to use its best judgment in choosing to respond or not to respond to any questions received before or after the above stated cut-off date for questions.

## 4. Proposal Submission. SUBMIT ONE PDF: "FIRM NAME"

**4.1.** Proposals are to be provided to the Issuing Office in accordance with the Solicitation Schedule. Proposals that are submitted electronically must be attached to an e-mail in portable document format (.pdf). Hyperlinks to software products sent to PGCC's Issuing Office that indicate that the Proposal is posted/available by the Proposer on an electronic site may be rejected or considered non-responsive (1) if contract terms and conditions (i.e., a Click-Through Agreement) are required to be accepted by PGCC in order to download the Proposal (2) the proposal is not easily accessible or (3) can be modified after submission. By providing the Proposal to PGCC electronically, the Proposer grants the College the unlimited right to generate additional electronic and/or paper copies for distribution solely for the purpose of evaluation and review.

The College may deem a submission non-responsive if received after the due date and time. The date time the email is received by the Procurement Officer shall be the official date and time of submission to Procurement, not the date and time the Proposer "sent".

- **4.3** Proposals will not be opened publicly. The identity of Offerors will not be disclosed prior to the Contract Award.
- 4.4 The Proposal, either individually or collectively, is considered by PGCC to be an Offer.

#### 5. Minority Business Enterprises (MBE) and Local Businesses.

Minority participation is important to PGCC. Prince George's Community College strongly encourages qualified local minority businesses and local business to provide goods and services for the performance of College functions. Minority Business Enterprises (MBE) firms are strongly encouraged to respond to this solicitation. An MBE is defined by the College as follow: <u>A Minority Business Enterprise (MBE) is any legal entity, other than a joint venture, organized to engage in commercial transactions which is at least 51% owned and controlled by one or more minority persons (African Americans, Hispanics, American Indians, Asians, women and the physically or mentally disabled), or a non-profit entity organized to promote the interest of the physically or mentally disabled.</u>

Although State certification is not required, Offerors shall be required to provide adequate proof that each MBE proposed/utilized meets the College's requirement/status and be required to execute the College's MBE Affidavit or other execute/provide other required documents determined by the College, at a later date.

Potential proposers that are not certified by the Maryland Department of Transportation (MDOT), are encouraged to initiate certification as soon as possible. ## **MBE Contract Participation Goal/Commitment: 15%**

The MBE goal is the minimum percentage the awarded vendor will retain for MBEs of the total overall contract(s) value that is established for this solicitation/awarded contract, unless waived by the College. This subcontracting goal will become part of the contract. The MBE goal may be fulfilled by an MBE prime, if awarded the contract.

Proposers are to provide within their proposal a completed and signed MBE Utilization Affidavit and include a completed MBE Participation Schedule. Proposers are strongly encouraged to include local (Prince George's County based company/ies) MBEs within your firm's proposal. <u>The Procurement Officer may deem the proposal not susceptible of the award, if the MBE documents are not provided within the Proposal.</u>

#### 6. Acceptance of Terms and Conditions.

By submitting a Proposal, an Offeror shall be deemed to have accepted the terms, conditions, and requirements set forth in this RFP. The RFP including all addenda in total shall be incorporated into the Contract by reference. Any exceptions to the terms and conditions shall be submitted as specified in the Response Requirements section of this Solicitation. Contract exceptions not provided in the format required under this RFP shall not be accepted nor be made part of any Contract, if awarded.

## 7. Contractual Agreement and Term.

It is intended that one (1) awarded firm will result from this Solicitation.

Any Contract arising from this RFP action shall commence on the date the Contract is executed on behalf of PGCC, or such other date as PGCC and the Contractor shall agree.

## 8. Confidentiality of PGCC's and Offeror's Information.

## 9. Post-Award Confidentiality.

## SECTION II. SCOPE OF WORK

#### 1. General Overview:

In April of 2018, Prince George's Community College opened the Culinary Institute Building which provides instructional culinary arts for PGCC students. To ensure the kitchens and the equipment utilized functions properly and to meet necessary kitchen safety codes and regulations, the College seeks a qualified and experienced Contractor to provide ongoing and as-needed deep cleaning services. Contractor shall provide all the necessary professional labor, cleaning, and maintenance equipment, and professional and safe, cleaning products and chemicals to meet the Colleges requirements either issued under these solicitations or provided later. The College representative will conduct walk-through inspections at the end of each service. The College shall approve the completion of services or issue to the Contractor a list of deficiencies for the Contractor to correct, at no cost to the College, unless the services are deemed by the College as additional services beyond the required contracted services.

Additionally, the College may request commercial kitchen cleaning services at the Dr. Dukes Student Center and Center of Performing Arts.

Services shall include, but is not limited to the following:

Other locations may be included, at a later date as needed by the College. Equipment is subject to change at the College's discretion.

Cleaning Services may include but are not limited to:

#### Cleaning of:

- \*Ceilings, walls, and base boarding, doors, floors, and walls under and behind equipment, door frames, light switches and wall plates, backsplashes, sinks, cabinets, baseboards and cove base, door jambs and behind doors, windowsills and ledges, entries and exits to all kitchen areas, floor edges and corners, any alcoves, prep table legs, wheels, undersides, racks, shelving units to pantries, and storage areas.
- Heating and air conditioning vents, (both intakes returns as well as output grills).
- Light fixtures (both inside and outside).

- Hoods, hood filters, grease troughs and catch pans, grills, griddles, fryers, ovens, mixers, boilers, broilers.
- Refrigerators, freezers, walk-in coolers, reach-in coolers, freezers (inside and out, including their floors 44eaZand shelving), temperature-controlled heating and cooling food-holding equipment, preparation tables, (topside, underneath, legs, and wheels), rolling carts, trucks, and food transport apparatus, sinks, garbage disposals.
- Refrigeration coils, fan motors, and their related housings are to be inspected, cleaned, and adjusted as needed for best performance as required by the manufactory warranty and the College's directive.
- All in-kitchen food preparation, food service areas, stone countertops, hard surfaces and under counter areas.
- Exterior grilling station and grill related equipment.
- Outdoor grill station and grill related equipment.

PGCC utilizes a commercial hood system and related duct work. Pressure washing will be required from its highest point. The highest point may be the building rooftop down to the interior duct that is located just above the cooking equipment. The system's filters, et. Al. shall be removed where possible and cleaned, all grease troughs cleaned out fan units should be inspected and adjusted as needed for best airflow on all deep cleaning.

The flooring is no-slip/grit-infused operational kitchen flooring.

Heavy duty degreasing, descaling, and complete deep cleaning, (ceilings to walls to floors), of all "back-of-the-house", (kitchen, food storage, food prep, food holding, and food service), areas of this approximately 36' high, two-storied, 21,500 sq. ft., and twelve (12) - roomed Culinary Arts Center.

#### Frequency/Schedule of Cleaning and Services Required

At minimum, the College anticipates, semiannual cleaning services. However, within the first three months of operations, the College may provide to the Contractor with greater certainty of the frequency required.

The frequency of services may change depending on use of the kitchens. The College does not guarantee a certain number of services need.

## Services shall be provided during the following days and times:

Monday – Friday, 10:00 PM – 6:00 AM Saturday, 5:00 PM – 6:00 AM

It is anticipated in January before the start of the spring semester, and in August before the startup of the fall semester cleaning services shall be requires to be "semester-ready."

Services are to meet the College's satisfaction, as determined by the College. The Contractor will be given one week, five business days to complete all cleaning services for the kitchens listed above.

## **Equipment and Supplies:**

- Contractor shall supply all the required cleaning supplies and equipment that is necessary to fulfill the services described this Solicitation.
- Must meet all safety hazardous requirements appropriate for the use of cleaning kitchen and equipment where food is prepared and served.
- As members of the Maryland Green Registry since 2009, it is also required of the Contractor to utilize recognized and approved, environmentally preferred products, services, and practices, i.e., CIMS-GB, GS-42, or similar "Low Environmental Impact Cleaning". Contractor shall practice "green cleaning" and procedures s to maintain the building's LEED certification.

# SECTION III. Article 1. PROPOSAL REQUIREMENTS

### 1. General Requirement

#### 1.1 Submission.

Proposals are to be provided to the Issuing Office in accordance with the Solicitation Schedule. Proposals that are submitted electronically must be attached to an e-mail in portable document format (.pdf). Hyperlinks to software products sent to PGCC's Issuing Office that indicate that the Proposal is posted by the Proposer on an electronic site may be rejected or considered non-responsive if contract terms and conditions (i.e., a Click-Through Agreement) are required to be accepted by PGCC in order to download the Proposal. By providing the Proposal to PGCC electronically, the Proposer grants the College the unlimited right to generate additional electronic and/or paper copies for distribution solely for the purpose of evaluation and review.

The College may deem a submission non-responsive if received after the due date and time. The date time the email is received by the Procurement Officer shall be the official date and time of submission to Procurement.

- 1.2 Transmittal Letter: A transmittal letter prepared on the Offeror's business stationery must accompany the Proposal. The letter should be an executive summary that clearly and concisely summarizes the content of the Proposal. The letter must be signed by an individual who is authorized to bind the firm to all statements, including services and financial statements, contained in the Proposal. Include the Offeror's official business address and state in which it is incorporated or organized (if Offeror is not an individual). An appropriate contact name, title, phone number, and email address should also be provided for PGCC's use during the procurement process. Do not include price information in the transmittal letter.
- 1.3 Signing of Forms: A Proposal, if submitted by an individual, shall be signed by the individual. If submitted by a partnership, a Proposal shall be signed by such member(s) of the partnership with authority to bind the partnership. If submitted by a corporation, a Proposal shall be signed by an officer, and attested by the corporate secretary or an assistant corporate secretary; if not signed by an officer, there must be attached a copy of a board resolution or that portion of the by-laws, duly certified by the corporate secretary, showing the authority of the person so signing on behalf of the corporation.

#### 1.4 Initial Criteria:

Clear, concise, yet detailed responses to the criteria below are to be provided in the Proposal. In addition, the Bid/Proposal Affidavit and Acknowledgement of Receipt of Addenda (if applicable) must be included. Standard sales material may be provided, but must be attached as an appendix rather than included within the body of the Proposal. Offerors must paginate the Proposal and are requested to provide tabs to separate responses to each of the criteria.

The following information must be furnished in the Proposal per this solicitation. Failure to include any of the items listed below may disqualify your firm's response. Offerors are requested to compile their Proposals in the same order. It is the Offeror's responsibility to tailor its response to demonstrate its qualifications to perform the scope of work specifically for PGCC.

#### 1.5 Response Requirements:

The following documentation must be provided in the response:

### • Company and Company Profile.

- A. Provide a brief history of the company including the number of years providing janitorial services with emphasis on the required functions specified in the Scope of Work above.
- B. Provide a minimum of three (3) client references, by using the provided Reference Form, see Appendix A (contact name, company name, and telephone number including extension numbers). If available, higher education references are preferred, but not required. PGCC reserves the right to contact references not provided in the proposal.
- C. Provide the name and contact information of the person assigned to this Contract as the Account Manager/Representative.

#### Pricing

Provide the one-time service fee inclusive of all services, equipment and supplies needed to perform the services as described in this solicitation. Vendors are to complete the Pricing Sheet included in this solicitation. See Appendix B, Pricing Sheet, attached.

The quoted rates and fees shall be valid for the initial term of the Contract and will remain in effect throughout the renewal terms of the contract, unless the Contractor submits a request in writing to the PGCC Procurement Office sixty (60) days prior to the end of each term. PGCC will have sole discretion to approve or deny rate increase requests. Rate increases above 4% will not be considered.

Pricing submission should consist of, but not limited to:

- Total Fee/Cost for services as described in this RFP- a fixed rate for all services required.
- Additional services, if other services are provided and the rates/fees.
- Contract Statement and Acknowledgement of Review of Contract: The PGCC Contract for this Procurement will contain the provisions in Appendix C (provided under a separate cover) as well as any additional terms required by the College. By submitting a Proposal, the Offeror warrants that they have reviewed Appendix C and will execute a contract: a) in substantially the same form; and b) with these terms and conditions upon request by PGCC. For accounting purposes only, PGCC will also issue a purchase order to the awarded Contractor.

Any exceptions to the Contract or terms and conditions are to be addressed and provided in this section of the Proposer's proposal/submission.

  - Acknowledgement of Receipt of Addenda Form: If any addenda to the RFP documents are issued prior to the due date and time for Proposals, this form (found in Appendix A) must be completed, signed, and included in the Offeror's Proposal.
  - **Proposal Affidavit:** Complete and sign the Proposal Affidavit enclosed in Appendix A and enclose with the Proposal.
  - Insurance: Provide a copy of a Certificate of Insurance verifying your firm's Coverage for Professional Liability, Commercial General Liability, Workmen's Compensation, Automobile Liability Insurance, and Professional Liability.

## 1.6 Modifications of Proposal.

Offerors may modify their Proposals by e-mail or facsimile communication at any time prior to the due date and time, provided that the Issuing Office is satisfied that a written confirmation of the modification with the signature of the Offeror was mailed prior to the Proposal due date and time. Proposals may not be modified, supplemented, cured, or changed in any way after the due date and time, unless specifically requested by the College.

#### 1.7 Contract.

The PGCC Contract for this Procurement will contain the provisions in Appendix C as well as any additional terms required by the College. By submitting a Proposal, the Offeror warrants that they have reviewed Appendix C and will execute a contract: a) in substantially the same form; and b) with these terms and conditions upon request by PGCC. For accounting purposes only, PGCC will also issue a purchase order to the awarded Contractor. Any exception to the Contract or terms and conditions are to be addressed and provided in this section of the Proposer's proposal/submission.

# SECTION III Article 2. EVALUATION PROCESS

## 1. Qualifying Proposals.

1.1 Procurement Officer Review: The Procurement Officer shall first review for compliance with the mandatory response requirements of this RFP (i.e., susceptibility of award). Failure to comply with any mandatory requirements will normally disqualify a Proposal. The College reserves the right to waive a mandatory requirement when it is in its best interest to do so.

## 2. Evaluation of Qualifying Proposals.

- **2.1 Initial Evaluation:** Following the Procurement Officer's qualifying review, the Committee shall conduct its evaluation of the merit of the Proposals in accordance with the response requirements. Minor irregularities contained in Proposals, which are immaterial or inconsequential in nature, may be waived wherever it is determined to be in the College's best interest. The decision for progressing in the procurement process will be made based on the strengths, weaknesses, advantages, and deficiencies that the Proposals represent.
- **2.2 Shortlisting:** In accordance with the response requirements set forth in in this RFP, a shortlist may be developed based on the Initial Evaluation results. All Offerors will be notified of the results as they pertain to their respective Proposal.

### 3. Interviews/Oral Presentations/Discussion Sessions. (If invited)

- **3.1 Purpose:** Based on the Evaluation Committee's Initial Evaluation, the College may invite, without cost to itself, the shortlisted Offerors to an oral presentation/discussion session ("Discussion Session"). The purposes of the Discussion Session are as follows:
  - (i) To provide the Offeror the opportunity to demonstrate its product/services;
  - (ii) To discuss/clarify any and all aspects of the Proposal, in particular the proposed Services/product, options, approach/methodologies, implementation process, schedule, staffing of the contract, and ongoing support of the product and other applicable professional services;
  - (iii) To allow the College to meet the Offeror's key personnel and for these personnel to convey directly their experience and expertise in the proposed services/product and its implementation; and
  - (iv) To provide an opportunity to clarify the scope of services for the intended contract and discuss any items addressed in the Proposal that may require additional clarification.
- 3.2 Format: The Discussion Session will be informal, as the College is not interested in a sales presentation by executives and business development staff; rather, the College is requesting evidence of the Offerors ability to meet the College's requirements and an interactive discussion with each of the shortlisted Offerors. It is important that those key personnel who are proposed to be assigned to the College fully participate in the presentation and discussion. Ample time will be available for the College and the Offeror to ask questions and discuss issues and concerns related to the product, the scope of the services, and the Offeror's capabilities and qualifications. We anticipate that the Discussion Session will be approximately 60-90 minutes in length, to be determined at a later date.
- **3.3 Date:** The times and dates for the Discussion Session(s) will be set upon completion of the Initial Evaluation; however, it is anticipated that the Discussion Session(s) will be conducted on the times and PGCC RFP #22-06 RFP Reissue from RFP# 22-01Instructional Kitchen Deep Cleaning Services

dates listed per the Solicitation Schedule, as well as on the cover of this RFP. Offerors are therefore advised to set this(ese) date(s) aside in its (their) entirety on the calendars of the appropriate key personnel.

#### 4. Second Phase Evaluation.

- **4.1 Criteria:** Following the Discussion Session held with shortlisted Offerors, a Second Phase Evaluation will be conducted. The Evaluation Committee will re-evaluate all criteria of the Proposals of shortlisted Offerors, incorporating assessments of the Discussion Session and outcomes of reference checks, if performed. The College reserves the right to make a determination that an Offeror is not shortlisted prior to completing reference checks.
- **4.2 Process:** Further shortlists may result as the procurement progresses. At each phase of the process, those firms that do not remain shortlisted will not progress in the procurement. All Offerors will be notified of the results of the Evaluation as they pertain to their respective Proposals. It is PGCC's intent to incorporate references prior to establishing the final shortlist of proposals. However, the College reserves the right to modify scoring if pertinent information regarding a Proposer's capability is obtain prior to an award. Once a final shortlist of proposals is established, the Committee will rank the remaining Proposals from highest to lowest.
- **4.3 Additional Technical Information or Technical Evaluation Phases.** The College may include additional technical requirements at any time during the procurement process to further ascertain the firms' technical capabilities. The additional information shall be issued to only Proposers shortlisted at any given phase to better determine technical capabilities that may result in a newly established shortlist of firm that will progress further in the procurement process.

# SECTION III ARTICLE 3. PRICING EVALUATION

#### Evaluation.

The College may elect to request Best and Final Price Proposals (BAFO's).

If applicable to the procurement, the Committee may establish a financial ranking of the final Financial and Price Proposals from lowest to highest total offers, separate from the technical response requirements. The pricing rating shall be incorporated/considered in the overall proposal score. The College reserves the right to review and rank pricing upon the completion of the technical review and/or the establishment of the final technical rankings. The College further reserves it's right to only review and evaluate the final topped ranked firms' pricing once the technical response requirements are evaluated, if evaluated separately.

# SECTION III ARTICLE 4. FINAL EVALUATION, RANKING AND SELECTION

#### 1. Recommendation of Award or Further Discussions.

The Committee may recommend an Offeror for contract award(s) based upon the Offeror's Proposal without further discussion. However, should the Committee find that further discussion would benefit the College, the Committee may recommend such discussions to the Procurement Officer. Should the Procurement Officer determine that further discussion would be in the best interest of the College, the Procurement Officer shall establish procedures and schedules for conducting discussions and will notify responsible Offerors.

### 2. Final Ranking and Selection.

- **2.1 Process:** Following evaluation of the Proposals (and Best and Final Offers, if applicable), the Evaluation and Selection Committee will make an initial overall ranking of the Proposals and recommend to the Procurement Officer the award of the contract(s) to the Offeror whose Proposal(s) is (are) determined to be the most advantageous to the College. The decision of the award(s) of the Contract will be made at the discretion of the Procurement Officer and will depend on the facts and circumstances of the procurement. All Offerors will be notified of the award(s) selection.
- **2.2 Basis for Award:** The College shall award on the basis of the Proposer's experience and pricing. Technical merit may have a greater weight than financial and price in the final ranking. Award may be made to the Offeror that demonstrates a high level of capability even if its fees and pricing is not the lowest. The Procurement Officer retains the discretion to examine all factors to determine the award of the contract. The goal is to contract with the Offeror(s) that would best meet the needs of the College as set forth in the RFP.
- **2.3. Negotiations:** The College may select for award one or more Offeror(s) to negotiate the terms and conditions of the Contract. The College reserves the right to make an award with or without negotiation. In the event negotiations between the selected contractor and the College fail to mutually agree on any terms and conditions, the College may rescind the award and conduct negotiations with the 2<sup>nd</sup> highest ranked firm/contractor. Additionally, if the Contractor fails to actively pursue the finalization and execution of the Contract, the College may rescind the Contract, at any time prior to the full execution of the Contract.

#### 3. Debriefing.

#### 3.1 Request:

Unsuccessful Offerors may request a debriefing. A request must be submitted in writing to the Procurement Officer within ten (10) days after the date on which Offeror knows, or should have known, that its Proposal was unsuccessful. Debriefings shall be conducted at the earliest feasible time. The College will not hold debriefing requests sent after 10 days from the notice of status.

**3.2 Discussion:** Debriefings shall be limited to discussion of the Offeror's Proposal only and shall not include a discussion of a competing Offeror's Proposal. The debriefing may include information on areas in which the unsuccessful Offeror's Proposal was deemed weak or insufficient. The debriefing may not include discussion or dissemination of the thoughts, notes, or ranking from an individual Evaluation Committee Member.
