Prince George's County residents are given priority for admissions. See the College Catalog for information about out-of-county admissions. Out-ofstate students are only considered for admission when the available seats are not filled by qualified Maryland residents. **Students attending the college on a non-domiciliary visa, as determined by the college, will not be considered for admission in any of these programs. To participate in clinical education courses, all students accepted into any of these programs must have a social security number, which will be verified as part of the background check. All students in the health science clinical programs require a criminal background check, drug screen, and health insurance**. Continued participation in each program is contingent upon a satisfactory response on the background check and drug screen. All background check and drug screen information remains confidential and is only shared with the requesting clinical agencies. If a clinical agency denies clinical program.

✓ Students must complete Developmental and ESL courses in Math, Composition, and Reading if required.

- ✓ All science courses must be within 10 years of petitioning
- ✓ ATI-TEAS is required: Proficient or higher with 70% in Reading

## Additional Information:

- The Allied Health and Nursing Petitioning Advisors are **Ms. Nicole Stubbs and Ms. Tamika McKelvin.** They will let students know when they should complete the <u>ATI-TEAS exam</u>. **Do not take the exam before meeting with them.**
- Deadline to petition (NUR 1000):
  - > The Allied Health and Nursing Petitioning Advisors petition a year in advance.
  - Schedule your Zoom appointment with a petitioning advisor once you are in EGL 1010, MAT 1250, or BIO 1050 or BIO 1010.
  - > The Fall petition deadline and ATI-TEAS scores are due by February 1.
  - > ATI-TEAS exam scores are due before you can get registered for NUR 1000.
  - > Students can not register for NUR 1000, schedule your appointment with the Petitioning Advisors.
- The LPN Certificate has a point system for selecting students. The Allied Health and Nursing Petitioning Advisors will discuss this with each student during your appointment.
- All students' majors must be <u>Health Science A.S. Degree</u> if you are interested in the Nursing program. Do not apply for graduation for this degree.
- Students must have an official evaluation completed by Admissions to petition or repetition.
  - > E-mail <u>transfercredit@pgcc.edu</u> to check the status of your official evaluation.
- All Students must follow current requirements to petition and/or repetition.
- LPN to RN program prerequisites can be completed in advance as well.
- All students are solely responsible for meeting their graduation and transfer requirements.
- If accepted into the Nursing Program a mandatory orientation is required if accepted. Failure to attend will jeopardize program enrollment.
