Prince George's County residents are given priority for admissions. See the College Catalog for information about out-of-county admissions. Out-of-State students are only considered for admission when the available seats are not filled by qualified Maryland residents. **Students attending the college on a non-domiciliary visa, as determined by the college, will not be considered for admission in any of these programs. To participate in clinical education courses, all students accepted into any of these programs must have a social security number, which will be verified as part of the background check. All students in the health science clinical programs require a criminal background check, drug screen, and health insurance**. Continued participation in each program is contingent upon a satisfactory response on the background check and drug screen. All background check and drug screen information remain confidential and is only shared with the requesting clinical agencies. If a clinical agency denies clinical placement for a student because of a background check, drug screen, or lack of health insurance, that student may not be able to complete the clinical program.

- ✓ <u>All science courses must be within 10 years of petitioning</u>
- ✓ ATI-TEAS is required: Proficient or higher with 70% in Reading

- All student's majors must be <u>Health Science A.S.</u> if you are interested in the Nursing program. Do not apply for graduation for this degree.
- Students must have an official evaluation completed by Admissions to petition or repetition.

- All Students must follow current requirements to petition and/or repetition.
- BSN Prerequisites: CHM 1010, NTR 1010, and MAT 1140. Allied Health and Nursing Petitioning Advisors will discuss more.
- If accepted into the Nursing Program a mandatory orientation is required if accepted. Failure to attend will jeopardize
  program enrollment.
